CONSTITUTION

Article 1 This body shall be called the Taylor County Association of Kentucky Baptists.

Article 2 Each member church in this body shall be entitled to four messengers, one of whom shall be the pastor, and one additional messenger for each fifty members above the first one hundred (100) members.

Article 3 The business of this body shall be, when assembled, to hear reports from the churches with regard to their condition as to members, prosperity, etc., to consult together for their development and growth in all matters pertaining to the evangelism of the world, and shall hold and control such property as shall come into possessions of the Association.

Article 4 This body shall exercise no authority over the local churches and recognizes their complete autonomy. The Association reserves the right, as final action, to sever relations with any member church for engaging in practices not considered Eiblical.

Article 5 This body shall, on meeting annually, elect by nomination and private ballot, or raising of hands, Moderator, First Assistant Moderator, Second Assistant Moderator, Clerk, Assistant Clerk, and Treasurer, whose duties shall be such as custom imposes on their respective offices. All officers shall continue in office until superseded by their successors, but no one shall be eligible to the office of Moderator for more than two successive terms.

Article 6 An opportunity may be offered for other churches to unite with body, and visitors shall be invited to sit with us with no power to vote.

Article 7 The Executive Board of the Association shall be composed of all pastors of member churches, and one lay member from each church. All general Association officers and auxiliary heads will by viture of their office be members of the Executive Board. Each Associational officer shall hold the same office in the Executive Board. The Executive Board shall have charge of the work between the sessions of the Association. Quorum of the Executive Board shall consist of nine members.

Article 8 In the appointment of committees, individuals shall be named instead of churches, and on each committee named, one or more members shall be laymen. The Promotional Committee shall consist of the Moderator, Clerk, Treasurer, and heads of the Associational Organizations, and such other members as the occasion may demand.

Article 9 This body shall meet annually, according to adjournment, but in case of emergency the Executive Board may call a special session, and also change the time and place of the meeting.

Article 10 This Constitution may be altered or amended (except Article IV) at any meeting of the body, upon one year's notice, by concurrence of two-thirds of the members present.

Parliamentary Rules: Kerfoot's Parliamentary Rules of Order is the guide of the parliamentary order followed in the Association.

BY-LAWS

ARTICLE I — DUTIES OF OFFICERS

1 Officers elected at the annual meeting shall assume their duties at the close of the meeting at which they were elected, with the exception of the clerk who shall assume office immediately following his election.

2 The Clerk shall keep a record of the proceedings of the Association and the Executive Board, superintend the printing and distributing of the minutes of the Association; send five copies of minutes to the Secretary of the General Association of Kentucky Baptists in Kentucky; keep a file of the minutes and other important papers of the Association.

3 The Treasurer shall receive all money contributed by the churches to the Association, or money from any other sources; shall make such disbursements as authorized by the Association or Executive Board and shall make monthly and annual reports to the Executive Board and the Association; he shall be bonded and the bonding fee paid by the Association.

4 An Auditor shall be secured by the Executive Board to audit the Treasurer's books and attest his annual report. The auditing expense, if any, shall be paid by the Association.

ARTICLE II — COMMITTEES

1 The Promotion Committee shall be responsible for planning, developing and promoting a program of activities for the year in all phases of church work. This committee shall give a monthly report of the progress of their program.

2 The Program Committee will plan the programs for the annual meetings, and shall report as far in advance as possible.

3 The Nominating Committee, after consulting with Auxiliaries of the Association, shall recommend to the Association at its annual meeting nominations for all Associational Sunday School Officers, all Associational W.M.U. Officers, all Associational Training Union Officers, all Associational Brotherhood Officers and such other officers as the body may from time to time assign them.

4 All committees shall be appointed by the Moderator, unless otherwise specified by a separate motion.

5 The term of no committee shall exceed one year unless by special vote of the Association.

6 Each committee will be automatically discharged when its final report is accepted by the body.

10. Christian Education:

The report on Christian Education was given by Dr. Paul Horner and adopted. Dr. J. Chester Badgett and Dr. D. L. Druen spoke to the report.

REPORT ON CHRISTIAN EDUCATION

The Christian Education Advance Campaign is now consuming most of our attention and this is certainly as it should be because the campaign is so vitally related to the total program of Kentucky Baptists. Up until now one-third of the goal of nine million dollars has been pledged with only about one-fourth of our church members being solicited.

The decision to close Bethel College at the end of the academic year 1963-64 provided a note of sadness for us all. We are grateful for the trustees, President P. Harris Anderson, faculty and local leader who went the extra mile in deliberations pertinent to the closing. Our own college at Campbellsville has participated prominently in the closing of Bethel having received the records of the institution and the greater part of the library.

Our six colleges and schools are growing in favor with our people. All report record-breaking pre-enrollments for the fall term. We now have four senior colleges: Campbellsville, John M. Carter, president; Cumberland, J. M. Boswell, president; Georgetown, Robert L. Mills, president; Kentucky Southern, Rollin S. Burhans, president. In addition we have one fine Baptist High School in the mountains, Oneida Baptist Institute, David C. Jackson, president; and a school for preachers without college training, Clear Creek Baptist School, D. M. Aldridge, president.

In the world of industry, commerce, research, science, government and world affairs the clamor today is for trained leadership. Our young people are going to college at the rate of one out of three high school graduates. Christ-centered training to raise the "seed-corn" of leadership for our nation and churches from our Christian colleges is imperative. We must not fail our young people, our nation, our God in our failure to respond generously and wholeheartedly to the call of our Christian Education Advance.

We are urging that this association adopt the following suggestions for implementing the campaign:

1. That a C. E. A. organization in the Association be continued until the job is done with a pastor chairman.
2. That every church in the association adopt its suggested C. E. A. goal or some goal within the church's ability by December 1, 1964.

3. That every church conduct a campaign of solicitation to all its active members.
4. That every Baptist give earnest and prayerful concern as to the amount of his contribution.
5. That every Baptist church leader give willing co-operation toward other auxiliary methods for the finishing of the campaign.

September 1963—New Student Union and Natural Science Buildings completed and occupied for the fall semester.

December 1963—Accreditation by Southern Association of Colleges and Schools. Recognition now established as a standard four year liberal art college by other colleges of the country.

August 1964—Largest summer school session in the history of the college with an enrollment of 402 students.

Kentucky Central Hotel-Motel now fully converted into a men's residence hall, accomodating approximately 120 single men students.

. Fall enrollment expected to exceed 800.

Faculty members 41, with 36.6% holding earned doctoral degrees, in accordance with accreditation standards.

Plans For The Future

One thousand students by 1966-1967, adequate library, laboratories, class rooms and other facilities already available to teach this number of students.

13. **Hospitals:**

The report on Hospitals was given by Rev. Joe Hargrove and approved. Rev. Hargrove and Rev. Robert C. Jackson spoke to the report.

REPORT ON HOSPITALS

One has only to be a patient or visitor in one of our hospitals to realize how great a work they are doing.

These hospitals located in Paducah, Louisville, and Lexington are continuing to grow in their healing ministries. Last year they admitted 35,978 patients and 5,331 babies were born. These hospitals employ 1,722 employees full and part-time.

Charged off as bad debts and discounts last year was \$326,736.45. From the Sunday School Charity Fund they received \$35,829.13. Kentucky Baptists gave \$32,946.00 to the fund last year.

These hospitals will accept needy patients who ever they are. Let's look deep in our hearts and give generously to the Mother's Day Offering to help

keep this Sunday School Charity Fund sufficient to meet the needs of those less fortunate than ourselves. Jesus said, "As you did it to one of the least of these my brethren, you did it to me."

14. Children's Home:

The report on Children's Homes was given and adopted. Bro. J. D. Hern-
don, Superintendent of Spring Meadows spoke to the report.

REPORT ON CHILDREN'S HOME

Last year the Kentucky Baptist Board of Child Care served more chil-
dren's homes and gave more money to support them than ever before in their
history.

The exact number of children receiving care was 792. Not all of these
were brought to the children's homes to live. Some received assistance from
Kentucky Baptists in their own homes. Others were placed in boarding homes,
and a few lived in free homes. Eighteen were college or vocational students.
Forty-six were infants born to unwed mothers, and placed for adoption.

Our Kentucky Baptist homes are dedicated to the purpose of bringing
children up in "the nurture and admonition" of our Lord. They continue to
merit our respect and confidence. All three—Glen Dale, Spring Meadows,
and Pine Crest are licensed by the Commonwealth of Kentucky as child care
agencies. Glen Dale and Spring Meadows are also licensed to place children.

Last year the three children's homes reported the conversion and baptism
of fifty-eight children.

In addition to the Thanksgiving Offering the Children's Homes are sup-
ported through the Cooperative Program, endowment income, special gifts,
legacies and devices.

The Board of Child Care has been moved to a new location at 305 Ever-
green Road, Middletown. It has been named, The Baptist Child Care Center.
Through this center, Kentucky Baptists, in the name of Christ, minister to
"these little ones" who are homeless and off-times forsaken.

15. Annuity Board:

The report on the Annuity Board was given by Bro. Richard Phipps and
adopted.

ANNUITY BOARD REPORT

Ever pastor, church and denominational employee is eligible for the new
group term Life Benefit Plan being offered by the Annuity Board, regardless
of whether they are a member of the board's retirement plans.

Cost is low—The new plan provides low cost life protection to members
while in active service, during disability or actual age retirement. Cost is only

1 per cent of the annual salary basis, with minimum basis of participation set at \$4,000 and maximum at \$12,000.

Benefits are large—The widow or beneficiary of a member 45 or under will receive 2½ times his salary basis of participation in the event of his death. Thus, the widow of a man 44 years of age who is paying on a \$12,000 salary basis would receive \$30,000. If death was accidental her benefit would be twice this, or \$60,000. After the member passes 45, benefits are scaled downward by 1/10 of a percent each year as he gets older.

More than \$43½ million have been paid in relief and annuity benefits by the Annuity Board since its beginning in 1918. Last year these benefits were more than \$3¼ million, and were paid to ministers and denominational workers or their families who were members of a retirement plan, and to those on the relief rolls.

During 1963 a total of \$123,540.70 was paid to 170 Kentucky annuitants and \$9,082.00 to 34 relief beneficiaries. Added to the annuity roll during the year were 20 people 11 age 1 disability, 7 widows, and 1 on the early age option.

As of January 1, 1964, Kentucky had 882 actively participating churches and 1,026 active members. Our work is supported by the Cooperative Program.

16. State Missions:

The State Mission report was presented and adopted.

STATE (DIRECT) MISSIONS REPORT

The Direct Missions program of the Kentucky Baptist Convention begins in the heart of the local church. It is the method by which a local church cooperates with other churches in our state sharing the Gospel with people in other communities in our state.

Last year our missionaries worked in 333 revival meetings. They conducted over 16,000 services in which almost 1,000 people made professions of their faith in Christ, 600 moved their church membership and more than 2,300 people made some definite public decision.

These workers reported 56,000 visits, distributed 180,000 pieces of literature, taught 2,200 study courses, helped in the organization of five new missions and 100 new organizational units and assisted in the construction of 15 new churches.

Since June 1, 1956, the Direct Missions Department has been responsible for the 30,000 Movement in Kentucky. During these eight years, 458 missions have been organized and 193 churches have been constituted. Six months remain for us to reach our original goal of 700 new units during the Baptist Jubilee Advance.

The Direct Missions Department is helping Kentucky Baptists to be more faithful in their acceptance and discharge of the responsibilities of world-wide missions, using the Cooperative Program as the chief means of implementation outside their own local community. If the ministry of the Direct Missions Department can assist us in our mission responsibilities in this association they are available to us.

17. Kentucky Baptist Foundation:

The report of Kentucky Baptist Foundation was given by Dr. J. Chester Badgett. Dr. Badgett spoke to the report.

REPORT OF KENTUCKY BAPTIST FOUNDATION

The Kentucky Baptist Foundation is a very important agency of the Kentucky Baptist Convention which is designed to give long term financial undergirding to all of our agencies and institutions according to the concern of individuals, churches, and other institutions. The Foundation has described its basic objective as follows:

- (a) To receive and invest, securely, and productively, funds and property in trust for the benefit of Baptist Institutions and Causes;
- (b) To create among our churches a climate of total stewardship, involving the capital assets as well as the present income of our members;
- (c) To provide a channel through which, by gift or bequest, our Baptist people can supply future needs as well as present support of Kingdom causes;
- (d) To present the opportunity to our people for tangible immortality and eternal reward.

The assets of the Foundation now total approximately \$3,500,000.00. The annual income on these investments will total about \$145,000.00 annually. The assets of the Foundation have reached the present value both through gifts and capital gains. The total received by the agencies and institutions for expenditure since the establishment of the Foundation amounts to \$778,266.11. The entire cost of operation of the Foundation come from the Cooperative Program.

Dr. A. M. Vollmer, who has served as Secretary since the Foundation's inception and who will retire at the end of this month, has done a monumental work in this important position. He is to be succeeded by Dr. James C. Austin of Nashville.

18. Evangelism:

The report on Evangelism was given by Bro. Earl Pike and adopted.

REPORT ON EVANGELISM

Every serious minded Kentucky Baptist is deeply concerned about our evangelism report for this year.

The report indicates that during the year 1963 we received into our churches by believer's baptism 19,120 people. This is a decrease of $6\frac{2}{3}$ per cent from last year's record. The fact that the decrease in the entire Southern Baptist Convention was even greater than that in Kentucky should cause us to be more alarmed than ever.

Reports from associations and churches indicate that where the New Testament pattern of evangelism, personal and public, has been followed, people have come to a saving relationship with the Lord. These principles do not change. We must be willing to follow them faithfully.

In 1963, two associations, Twin Lakes and White's Run, had baptisms reported in every church. This is the third consecutive year in which White's Run has had such an excellent report.

Five associations, Booneville, Enterprise, Middle Fork, Pine Mountain and Three Forks, reported baptisms at the ration of one baptism for every twenty church members or better. This is the fourth consecutive year for such a report from Pine Mountain and the second year for Three Forks. There were 128 churches in Kentucky which reported baptisms at the ratio of one for every ten church members or better during this year. The sad thing is, 397 churches reported no baptisms during the year.

Seven churches reported 90 or more baptisms during the year.

They were: Walnut Street, Louisville, 140; First Baptist, Hazard, 115; Grace, Lexington, 108; Glendale, Bowling Green, 107; Ninth and O, Louisville, 98; Rosemont, Lexington, 95; Cumberland, Pine Mountain, 91.

The following results came from the evangelistic efforts in our association during the year: All Churches At Least One—Total Baptisms 222.

Let us continue to pray and witness, claiming the promises of God, with the objective of bringing at least one person to believer's baptism for every twenty members of our church during the next year.

20. Home Missions:

The report on Home Missions was adopted.

HOME MISSIONS REPORT

"This is home missions' most urgent hour. The entire world looks to America for Christian leadership, but America cannot give what she does not continue to have."

2,299 missionaries serve in every state, Cuba, Panama, and Puerto Rico.

More than \$6½ million came from Southern Baptists for home missions through the Cooperative Program, the Annie Armstrong Offering, and from other sources of income. This amounted to about 62 cents for each Southern Baptist, a nickel per month.

645 student summer missionaries served ten weeks in every state and Panama during the twentieth year of the ministry.

46,226 professions of faith were reported by the missionary force. This was a decrease from the 48,700 reported the previous year and reflected a like percentage decrease within the Convention, which reported 355,325 baptisms.

The 30,000 Movement, in its climactic year in 1964 reported by January 1 that 5,884 churches and 16,016 missions had been started.

All Kentucky Baptists should rejoice in the fact that the Home Mission Board is working jointly with the Direct Missions Department in \$80,000 worth of missions programs in our state. The Home Mission Board furnishes 48 per cent of this amount. These mission programs are language missions; metropolitan missions consisting of juvenile rehabilitation, and mission centers in Louisville, Lexington and eastern Kentucky, pioneer missions in West Virginia; urban rural missions in our eastern mountains; and National Baptist work.

21. Foreign Missions:

The report on Foreign Missions was given by Bro. Everette Lee and adopted by the Association. Dr. J. Chester Badgett spoke to the report.

FOREIGN MISSION REPORT

Through May, 1964, Southern Baptists have in active service 1,819 Foreign Missionaries with many urgent requests as yet not filled.

Southern Baptists have missionaries in 54 different countries with a varying number of institutions on each field—churches, schools, hospitals, publication plants, good will centers, but the goal of each is evangelization.

In 1963, national pastors number 2,822. Most of the churches have Sunday Schools and other church-affiliated organizations. The 3,943 churches and 6,999 chapels reported 540,849 enrolled in Sunday School, 41,147 baptisms, and 523,603 church members.

In 1963, Cooperative Program gifts from Southern Baptists for foreign missions totaled \$21,431,202.10 (Ky. \$438,835). This is \$3,000,000 short of requests from Missions for more land, buildings and equipment. Funds from the 1963 Lottie Moon Christmas Offering totaled \$10,949,857.35 (Ky. \$396,861).

Educational work offers opportunity for evangelism and also trains strong national leadership. The 1,076 Baptist schools enroll 170,536 students and have 6,160 national and 328 missionary teachers. Among the schools are 39 theological institutions with 1,470 students and 6 women's training schools with 509 students.

Medical mission institutions include 19 hospitals and 41 clinics. There are 57 missionary and 99 national physicians, plus 55 missionary and 209 national nurses. The primary aim of missionary medicine is the healing of the whole man—both spiritually through a personal knowledge of Jesus and physically through the best practice of medicine.

We as Southern Baptists must measure our mission understanding by our potential—not by what we or others have done. We must measure what we are doing by the crisis of our day. This is the day of destiny.

22. Sunday School Report:

The Sunday School report was given by Rev. B. T. Chaffin and adopted. Rev. Chaffin spoke to the report.

REPORT ON SUNDAY SCHOOL

THEME: The Sunday School Helping the Church to Fulfill its Mission through:

1. Bible Study: The Source of Christian Enlightenment
2. Outreach: The Expression of Christian Compassion
3. Worship: The Secret of Spiritual Depth

The goal of 10,000,000 enrolled in the Sunday schools of the Southern

Baptist Convention by 1970 is worthy and realistic. With millions of people not engaged in any systematic plan of Bible study, the task to enroll them in Sunday school becomes imperative.

Kentucky's enrollment goal for 1964-65 is 437,467.

The following suggestions are offered all churches:

1. Lead your Sunday school to adopt a worthy enrolment goal.
2. Use "Adult Thrust" for outreach.
3. Give special attention to starting new Sunday schools and/or Extension Bible Classes.
4. Use the Cradle Roll and Extension Department to enlist more in Bible Study.
5. Enroll in Sunday School Vacation Bible School pupils not at present enrolled.
6. Train Sunday school teachers through study courses on administration and teaching.
7. Plan well every phrase of Sunday school work at the first of the Sunday school year.
8. Use the Sunday school Witnessing Campaign.

The special emphasis this year is placed upon worship.

Sunday school goals for Kentucky 1964-65 are: Enrollment 437,457; Total Training Award 77,000, Annual State Convention Attendance 1,500; number of churches and missions with Sunday school 2,229; Standard Associations 4; Standard Sunday schools 150; Standard units 550; number of Vacation Bible schools 1,875; Vacation Bible enrolment 176,184.

Our Association reports this year 19 Sunday schools. A Sunday school enrolment of 4,125. There is 2.4% decrease in enrolment over last year. There was 4 Standard Sunday Schools; 222 Baptisms; 19 Vacation Bible Schools; 7 churches doing training; 457 awards earned. Our Association did not reach the standard.

23. Baptist Student Union:

The report on Baptist Student Union was given by Bro. Charles Hedrick and adopted.

REPORT ON BAPTIST STUDENT UNION

Enrollment

The school year of 1963-64 brought an all time high in Kentucky college enrollments. This past year there were some 54,538 students enrolled. It is said that the most rapid growth on our campuses will be before 1970.

By having a larger enrollment in our colleges, this helped to increase the

enrollments within our Baptist Student Unions. There were 14,105 Baptist students on 38 campuses and 2,138 of these were enrolled in our Baptist Colleges. There were 11,967 students enrolled in non-Baptist Colleges.

For the past several years we have seen a decrease on Baptist students being enrolled in Baptist schools. In 1958 19.4% of the Baptist students were enrolled in Baptist schools. When the 1963 school year began, there was an all time high in enrollments of our Baptist students, but only 15.2% of them were enrolled in a Baptist school.

BSU Work

Today we have a Baptist Student Union work on 19 campuses. There were 5,304 Baptist students invlived in BSU work. This is the highest percentage of Baptist students engaged in this type of work in any southern state.

There were 97 student conversions reported last year.

Workers

We have eight full time BSU Directors employed by the Kentucky Baptist Convention. Three other part-time workers are provided by Baptist institutions. There is an immediate need for six additional directors and eight assistant directors are in desperate need.

Student Centers

The Kentucky Baptist Convention owns seven Student Centers in Kentucky. Not one of these centers is adequate. Unless more money for Student Centers is provided through CEA or from some other source to enable us to build these new centers and enlarge the others, we may be forced to close our work on some campuses. A successful Christian Education Advance campaign will be the answer.

We need as Kentucky Baptist pray that God will open the hearts of our Baptist Churches and people that these needs may be reached and that we may be able to maintain a Christian intiuence on our students, the state and the whole world.

We are concerned and should be for our lack of interest in Training Union work. Due to this more of our church members are missing a great opportunity to learn how to serve our Lord. Where else in a church program can you better secure workers and officers for your church than from an active Training Union membership?

From October to June our association earned 643 awards, with only 8 of these awards in Training Union work. This is an increase of 39 awards over last year. These awards were earned by 7 out of 20 churches and missions.

"M" Night for 1963 was held at Campbellsville College Gymnasium with an attendance of 398. Our speaker was Bro. Haskell Bolding, of Corbin, Kentucky. We were grateful also to the College Choir for their music.

This year "M" Night will be December 7 at Campbellsville Church. Let us make this not only a high attendance night but may we come expecting great things from the Lord.

This year we had 5 fine young people participate in the Drills. We had 2 in Speaker's Tournament, 19 and above; 2 in Intermediate Sword Drill, and 1 in Junior Memory Work. These all came from Campbellsville and Pleasant Hill Churches.

We need to help establish our Training Union to be 100% in our association. Two visits on Sunday nights have been made to help in this and we will make more if necessary.

Our youth organizations are doing a wonderful work. Our Y.W.A.'s, G.A.'s, and Sunbeams have held associational meetings. Miss Rosa Feichter, State G.A. and S.B. One woman from our Association served as counselor at G.A. camp at Cedarmore. The quality of our work is measured by Aims for Advancement with Approved, Advanced and Honor recognitions. Two of our G.A. organizations—Lowell Avenue and Mt. Gilboa attained Honor recognition last year.

26. Radio and Television:

The report on Radio and Television was given by Bro. Floyd Short and adopted.

REPORT ON RADIO AND TELEVISION COMMISSION

Radio and Television is a rapidly growing department of our Convention program.

As was true of 1963 we find a greatly enlarged program in 1964. This year will be according to plans far advanced over any year of our Radio and Television Commission.

The three networks, NBS, CBS and ABC, have increased by over 60% their allocation of time to the Commission. Fourteen television appearances totaling eight hours of time are already scheduled, with equal increases in network radio.

Included in Southern Baptists' presentation for 1964 will be an hour-long documentary in color by the Commission on Missionary Journeys of the Apostle Paul, entitled, "Walk Beside Me,"—this was shown in May at the Southern Baptist Convention and Baptist Jubilee at Atlantic City.

On the local scene there was a net gain of 175 Radio Stations carrying Southern Baptist programs produced by the Commission. Different weekly programs produced during the year rose from 10 in 1962 to 18 in 1963 while the total number of stations increased from 1210 to 1367 during the year.

Dr. Herschel H. Hobbs has continued to grow in popularity as the preacher of "The Baptist Hour" his expository messages and his ability to make the scriptures live have established this program in the lives of Southern Baptists.

Printed sermons are sent to listeners who request them. The Commission's monthly magazine, "The Beam" had a circulation of more than 50,000.

The Radio and Television bids to be one of the most influential departments of our work in the future. The headquarters for the Commission is now permanently located in Fort Worth, Texas, and new quarters are being built to make possible an ever-widening program of our Baptist Life.

REPORT ON AMERICAN BIBLE SOCIETY

The work of the American Bible Society during the past year, the following data are respectfully submitted:

The American Bible Society continues to grow as an active partner of Southern Baptists in the missionary task of sharing Christ around the world. They have, during 1963, just passed,

6. Provided Scriptures in 444 languages and dialects.
7. Published "One Way For Modern Man," the J. B. Phillips translation in modern English of the Gospel according to St. John, now in its second printing, and issued the first ABS Revised Standard Version Bible.

REPORT ON COOPERATIVE PROGRAM

When he gave us our marching orders found in Matt. 28:19-20, known as the great commission, he knew it would take a spirit of cooperation to carry out his program.

Your part as an individual may seem small, but cooperating with 630,000 other Kentucky Baptists your gift grows.

Each individuals part might be:

1. Be as active as possible in your own church—Visiting,, Praying, Singing in Choir, Teaching, Serving on Committees.
2. Inform yourself. Read the Western Recorder, The Commission, and Home Mission Magazines. Study WMU, Brotherhood and Training Union literature.
3. Pray. Each day, remember to God in prayer, the world-wide ministry of Southern Missionary Baptists.
4. Give tithes and offerings. Your own church needs your gifts, Cooperative Program ministries need your gifts. You need to give for the blessing and spiritual power it brings to your own life.

STEWARDSHIP REPORT

"Honor the Lord with thy substance" (Prov. 3:9) is the stewardship scripture for 1964. When a Baptist is taught to give with the right motivation the Lord is honored, the individual is blessed, and the total program of Southern Baptists is undergirded.

Every church has the responsibility to develop its members in stewardship. There is no excuse for a congregation of intelligent Baptists not having a workable budget. Help is available through our Stewardship Department, of which Dr. Robert J. Hastings is Secretary, to meet the program needs of every church. Ignorance need not be an excuse.

During 1965-66 the Southern Baptist Convention, of which we are a part,

has set for itself the task of enlisting two million tithers. This will amount to about 20% of the membership of our churches. On the basis of last years figures this will be 1096 for the churches of Taylor County.

Your committee brings the following recommendations:

1. That we accept a tither's goal of 20% more of our total membership in 1965-66.
2. That we encourage each church to adopt a workable and God honoring budget.
3. That we encourage each church to put on a stewardship emphasis to challenge every Baptist to be a tither.
4. That we encourage each church to support associational missions according to the needs of the associational program and the strength of the church.
5. That we encourage each church to increase the amount of support through the Cooperative Program.

31. Brotherhood:

The report on the Brotherhood was given by Paul Ford and adopted. Dr. Forest Shely and Bro. J. D. Crawley spoke regarding their trip to the West Coast, which was sponsored by the Brotherhood.

BROTHERHOOD REPORT

Since this body met in its last annual session, the Lord allowed Kentucky Baptist to provide 13% of the total Brotherhood enrolment increase in the Southern Baptist Convention. Total enrolment now stands officially at 634,651. 389,995 are men and 244,656 are boys enrolled in RA Chapters.

Of the 28,428 in Kentucky 16,549 are men enrolled in Brotherhood and 11,789 are boys, members of RA Chapters. Brotherhood work is now found in 823 churches. In short we find Brotherhood work doubling twice in the past 12 years. Since 1957, boys enrolled in RA Chapters have more than doubled. Consequently the slogan "A million Men For Christ," is fast becoming a reality. Really numerical figures do not express the desire of any heart as it relates itself to Brotherhood work. (1) We are just touching a bare minimum of boys in RA program. (2) More of our men ought to practice daily Christian witnessing. (3) Missions still wait on personal stewardship. (4) Our Cooperative Program needs fuller understanding. (5) More men should attend local and state meetings. (6) Our men should see to it that every boy has the opportunity to attend a state RA Camp.

The Taylor County Association can be proud of the Layman's Led Crusade that was held in California in July 1964. The Association voted to send

four Laymen to this Crusade and pay their Air Line ticket both ways. Dr. Forest Shely, Jack Arvin, J. B. Crawley and Eugene Smith made this trip and the experience that they received was worth far more than the cost to the Association.

Your Association leader hopes that every church will do 3 things this coming year. (1) Observe RA Weew, November 1-7. (2) Observe Baptist Men's Day on January 24 (3) Call on State Brotherhood Department at Middletown for any need in Brotherhood work.

In our Association we have 7 churches with organized Brotherhoods. The total enrolment is 371 of this number 172 are boys enrolled in R.A. Chapters.
